

Patent Office Raises IP Questions For Tribes

Overview

Upcoming webinars and contributed commentary will shape future federal positions on 18 intellectual property questions that impact tribes. Tribes and inter-tribal organizations are encouraged to participate in consultations and to submit written comments to provide input on important matters concerning indigenous intellectual property rights.

The Request for Comments from the U.S. Patent and Trademark Office (USPTO) presents 18 questions around genetic resources (GR), traditional knowledge (TK) and traditional cultural expressions (TCEs). A series of tribal webinars and consultations are scheduled for January 2024, and written comments are due in February 2024.

The USPTO seeks input on how the **World Intellectual Property Organization** should best protect GR, TK and TCEs of Indigenous People, including whether such should be considered "public domain" or should receive grants or acknowledgments of exclusive rights or protections.

At-a-glance definitions



GR: Genetic Resources,

including "genetic material of actual or potential value" consisting of plant, animal, microbial, or other origin containing functional units of heredity.



TK: Traditional Knowledge,

including knowledge passed from generation to generation, in any form, and linked with a national or social identity of Indigenous Peoples/local communities, including know-how, skills, innovations, practices, teachings, and learning.



TCEs: Traditional Cultural Expressions,

generally not attributable to individual authors, but used (can be secret/sacred or public/commercial) and developed within a community in the form of literature, music, dance, games, mythology, rituals, handicrafts, religious and sacred texts, arts and customs, expressions of faith, and ancient beliefs.
