Airbnb announced this past week the appointment of outgoing American Express CEO, Kenneth Chenault, to Airbnb's board of directors. Chenault's appointment is his second in as many weeks (the first was with another small ecommerce company called Facebook).

Chenault's appointment is viewed by many as yet another step by Airbnb toward its highly anticipated public offering. In his statement announcing Chenault's appointment, Airbnb co-founder and CEO, Brian Chesky, also announced that Airbnb would be introducing in late February substantial improvements to its platform that would set Airbnb up for an "infinite horizon."

Earlier this month we included a [story](#) about a California federal district court's recent dismissal of a class action brought against Airbnb by a group of Southern California apartment management companies

alleging that Airbnb's listings violated the plaintiffs' tenants' leases. Recall that the leases contained express prohibitions against short-term rentals, including a specific reference to Airbnb in the subject language. Aimco, one of the plaintiffs in the recently dismissed suit, appealed the dismissal this past week to the Ninth Circuit Court of Appeals, re-asserting its same breach of lease claims. We will continue to follow this appeal and update our readers when a decision is issued.
